Texas Candidates for Delegate/Alternate to the 2008 Democratic National Convention must file this prescribed form, including all required information, with the State Democratic Party, 505 W. 12th St., Ste. 200, Austin, TX 78701. **We cannot accept this form earlier than April 21st nor later than 5 p.m. on May 21st.** It would be advisable to either hand deliver it or send it by certified mail, return receipt requested. **We cannot accept faxed filing forms.** Please print or type all information and have the form notarized before forwarding. Copies of the State Party Rules, including the 2008 Texas Delegate Selection Plan, are available from the Party Office or for download on our website at www.txdemocrats.org.

Note: Any candidates for a National Convention Delegate/Alternate seat MUST fill out this form to even be considered for election to the National Convention; however, filling out this form does not guarantee that you will be elected as a Delegate or Alternate to the National Convention. The completed forms will be sent to the respective Presidential candidates who are entitled to a right of review for all prospective National Delegates/Alternates who pledge their support for that candidate.
